



Addressing COVID-19 Together

Five Working Groups:

- Breast Cancer
- Colorectal Cancer
- •Lung Cancer
- Prostate Cancer
- Hospital/Cancer Center

Operations



Each group will:

- Evaluate existing evidence and guidelines, combined with sharing their own experience, expertise, and knowledge
- Collaboratively develop statewide consensus protocols/best practice guidelines for oncology care during each phase of the COVID-19 pandemic
 - Focus on reactivation, future surges
- Eventually, consider metrics to assess uptake
 - Only if of value to our member hospitals



Potential ILCC COVID-19 Cancer Care Topics

Breast	Triage algorithms for timing/urgency of surgery and reconstruction
Colorectal	Alterations to systemic therapy protocols
Lung	Triage algorithms for choice of systemic therapy vs. surgical resection
Prostate	Alterations to radiation therapy protocols
Operations	Criteria for access to clinics, care areas (infusion, radiation) based on COVID-19 exposure risks and prevalence (i.e., additional surges)

ILCC Consensus Guidelines for COVID-19 Cancer Care

The ILCC Approach

- The ILCC will be an **ongoing initiative**
- Training in Quality Improvement (QI)/Process Improvement (PI) methods
- Centralized resources to support implementation ("Coordinating Center")
- Mentorship for local Cancer QI Teams
 - Mentors: oncologists with QI/PI experience
 - Coaches
- Augmented Registry Data
 - Process Measures
 - Performance Reports
- Support from Commission on Cancer
- No cost to hospitals for participation



Illinois Commission on Cancer (CoC) Partnership

- Partnering with Illinois State Chair: Urjeet Patel, MD
- CoC hospitals receive feedback through the NCDB
 - Relatively few meaningful measures reported; most measures delayed
 - Few opportunities for improvement most RQRS measures topped out
 - Hospitals often find it difficult to use NCDB data to inform QI efforts
- The Future: ILCC hospitals report customized, focused metrics around actionable issues important to the collaborative
 - ILCC hospitals will receive state-specific benchmarking reports
 - Coordinating Center has extensive experience working with registry data abstractors to build measures that consider the abstraction burden
- For non-CoC accredited centers, we will work with you individually to develop solutions


Improve processes and outcomes for both patients and providers
